1. **Proof of insurance** coverage for Public Liability, property damage and passenger hazard in amounts not less than \$2,000,000.00 per vehicle, shall be required prior to the issuance of any license.

2. **"Certificate of Mechanical Fitness"** from a facility approved by the Ministry of Transportation must be provided to the Municipality for each vehicle for which a license is issued on a bi-annual basis, within 30 days of the anniversary of the license issuance, for all vehicles with less than 200,000 kilometers For all vehicles with more than 200,000 kilometers a "Certificate of Mechanical Fitness" is required annually or every 50,000 kilometers, whichever occurs first.
